National Institute of Technology Nagaland is one of the newly established Institutes by MHRD under the NIT Act 2007 to impart technical education and to promote research activities in the North East region. There are 03 numbers of existing deep tube wells in the campus which need maintenance by cleaning/washing and repairs. Also 4 (four) number of submersible 5 HP pumps are required for the three bore wells.

Sealed Quotations under two cover system (Technical & Financial) are invited from reputed firms/contractors for Repair, Fitting & Re-Installation of 3 Nos. of Deep Tube Well and Supply of 04 Nos. of Brand New Submersible Pump at NIT Nagaland as per the detailed Schedule given in the Annexure-II, so as to reach the office of the Registrar on or before the scheduled date and time. Detailed tender document can be downloaded from the Institute Website at URL <http://www.nitnagaland.ac.in>.

The bidder shall be required to deposit the earnest money (EMD) for an amount of Rs. 20,000/- (Rupees Twenty Thousand only), which is refundable and a tender document fee for an amount of Rs. 3,000/- (Rupees Three Thousand only), which is non-refundable by way of Demand Draft only. The Demand Draft shall be drawn in favour of “IRG NIT Nagaland” payable at Chumukedima, Dimapur. **The Demand Drafts for Earnest Money Deposit & Tender Document fee must be enclosed in the envelope containing the technical bid.**

The tender document shall be submitted in a sealed envelope bearing the following reference on the top left corner: **NIT-N/EO/2019/06-04, latest by 13th July 2019 at 12.00 p.m.** and addressed to: The Registrar, National Institute of Technology Nagaland, Chumukedima, Dimapur, Nagaland - 797103

Bid(s) received beyond the due date of submission will be rejected. No tender document will be entertained by E-mail / FAX. The Institute shall not be responsible for any postal delay about non-receipt / non-delivery of the tender documents.

Technical bid(s) will be opened on 13-07-2019 at 2.30 p.m. in the Conference Hall, Administrative Block of the Institute in the presence of the bidder(s) or their authorized representative(s) who are present at the scheduled time. The Financial bid(s) of the technically qualified bidder(s) will be opened on 13-07-2019 at 3.30 p.m.

In the event of the due date of receipt and opening of the tender being holiday/declared as holiday for the Institute, then due date of receipt / opening of the tender will be the next working day at the same time.

The tender document duly signed and stamped on each page shall be submitted in original with the Technical bid as a proof to confirm the acceptance of the entire terms and conditions of tender. Any amendment and / or addition made to the tender are not permissible after opening of the tender. Incomplete tenders will be rejected.

The Institute reserves the right to reject any or all tenders, wholly or partly or close the tender at any stage prior to award of contract without assigning any reason whatsoever.

1. ESSENTIAL QUALIFICATIONS FOR REPAIR, FITTING & RE-INSTALLATION OF 3 NOS. OF DEEP TUBE AND WITH SUPPLY OF 04 NOS. OF BRAND NEW SUBMERSIBLE PUMP AT NIT NAGALAND

- a) Contractor should have executed one similar works at any Central / State Government Educational / Research Institute or Institute of National Repute amounting to value not less than 5 lakhs within the last 3 years.
- b) The contractor should be registered/empaneled with CPWD/NPWD or Government Department executing such similar works.
- c) The bidder must have Work Orders for similar works amounting to Rs. 5.00 lakhs within the last three years.
- d) The bidder should furnish the certificate of PAN and GST registration number.
- e) The bidder should produce back up documents like purchase orders, work completion certificates for the above mentioned work.
- f) The bidder should assure and submit self-certificate for availability and supply of spares for next 3 years for the materials to be supplied.
- g) The Bidder has to quote for all the items in the tender as a package. Bidders who do not quote for all the items as per the given Tender Specification/Schedule are subject to be disqualified.

Note: All the supporting documents should be attached with the Technical Bid, without which the tender will be rejected. The bidder need to bring the above original documents at the time of technical opening for the verification.

2. INSTRUCTIONS TO BIDDER

Tender should be submitted in two covers, **Cover-I (Technical Bid)** and **Cover-II (Financial Bid)**. Envelopes of technical bid and financial bid should be individually sealed and then placed in a common outer cover which shall also be sealed and super scribed with the tender reference no. and due date of submission.

Cover-I: Technical Bid (Cover I should be superscribed as Technical Bid and indicating the Tender Reference No.)

1. The bidder shall be required to deposit the earnest money (EMD) for an amount Rs. 20,000/- (Rupees Twenty Thousand only), which is refundable and a tender document fee for an amount of Rs. 3,000/- (Rupees Three Thousand only), which is non-refundable by way of Demand Draft only. The Demand Draft shall be drawn in favour of “IRG NIT Nagaland” payable at Chumukedima, Dimapur. **The Demand Drafts for Earnest Money Deposit & Tender Document fee must be enclosed in the envelope containing the technical bid.**
2. Any technical bid without the Demand Drafts of Earnest Money Deposit and tender fee is liable to be rejected. The Institute is not responsible to pay any interest on such amount. Earnest Money Deposit shall be forfeited, if the tenderer withdraws its bid during the period of tender validity.
3. The Earnest Money Deposit of the successful bidder shall be refunded after the completion of contract/order. For unsuccessful bidder(s) it will be refunded after award of the contract.
4. The rate quoted should be valid for a minimum period of 90 days. No claim for escalation of the rate will be considered after opening the tender.
5. The Institute reserves the right to accept in part or in full any quotation(s) or reject any or more quotation(s) without assigning any reason or to cancel the tendering process and reject all quotation(s) at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s).
6. The representative of the bidders may be present during the opening of the tender document.
7. The safe delivery of items shall be the sole responsibility of the supplier.
8. A prospective bidder requiring any clarification of the tender document may communicate to the Registrar, NIT Nagaland

Cover-II: Financial Bid (Cover-II should be superscribed as Financial Bid and indicating the Tender Reference No. and shall contain Price only)

1. Financial bid should be enclosed in a separate sealed cover and should be written in the format (Summary Sheet) given in the tender document. Failure to provide price bid in a sealed separate cover will result in invalidation of the offer.
2. The bid should be clearly filled or typed and signed in ink legibly giving full address of the bidder. The rate should be quoted both in words and figures. All the pages of the bid should be duly signed by the authorized person affixing the seal. All corrections and overwriting should be initialled otherwise the tender shall be invalidated.
3. The rates should be quoted in Indian Rupee including all taxes and Freight charges at FOR destination at NIT Nagaland, Chumukedima, Dimapur - 797103.

Vendors shall submit the Summary Sheet I appended to the tender, duly filled in and shall be put in the technical bid cover and the Summary Sheet II duly filled in shall be put in the commercial bid cover.

3. OTHER TERMS & CONDITIONS:

- a) **Validity of Quotation:** Quoted rates must be valid for 90 days from the date of quotation.
- b) **Warranty:** The quoted items and components must be warranted for a minimum of 01 (One) Year or period specified against the item.
- c) **Quality Certificates:** Valid certificate to prove that the products are genuine and of International standard, as mentioned below, must be enclosed: (i) Manufacturer's certificate. (ii) ISO/ISI certificate.
- d) **Submersible Pump:** The Submersible Pump fitted and supply should be Brand New (Stainless Steel).
- e) **Delivery:** The successful bidder shall complete the work within 04 weeks from the award of the work order to NIT Nagaland.
- f) **Safe Delivery:** All aspects of safe delivery shall be the exclusive responsibility of the vendor. At the destination site, the package will be opened only in the presence of NIT user/representative and vendor's representative. The intact condition of the package and the seal/indicators for not being tampered with, shall form the basis for certifying the receipt in good condition.
- g) **Insurance:** The supplier is to establish 'All Risk Transit Insurance' coverage till door delivery at NIT Nagaland.

4. **Conditional tenders not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Conditions mentioned in the tender bids submitted by vendors will not be binding on NIT Nagaland.
5. **Late and delayed tender:** Late and delayed tender will not be considered. In case any unscheduled holiday occurs on the prescribed closing/opening date the next working day shall be the prescribed date of closing/opening.
6. **Payment:** The payment of 70 percent of the order value shall be released after repair and re-installation of the tube wells & Submersible Pump in good condition and 30 percent shall be released only after the inspection of the repair and installation of the tube well as per the specification jointly by representative from Bidder & NIT Nagaland.
7. The acceptance of the quotation will rest solely with the Director, NIT Nagaland, who in the interest of the Institute is not bound to accept the lowest quotation and reserves the right to himself to reject or partially accept any or all the quotations received without assigning any reasons.

8. **Force Majeure:**

If the performance of the obligation of either party is rendered commercially impossible by any of the events hereafter mentioned that party shall be under no obligation to perform the agreement under order after giving notice of 15 days from the date of such an event in writing to the other party, and the events referred to are as follows:

- i. Any law, statute or ordinance, order action or regulations of the Government of India,
- ii. Any kind of natural disaster, and
- iii. Strikes, acts of the Public enemy, war, insurrections, riots, lockouts, sabotage.

9. **Termination for default:** Default is said to have occurred;

- a) If the equipment or any of its component is found having poor workmanship, faulty designs, poor performance and bad quality of materials used.
- b) If the bidder fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by NIT, Nagaland.
- c) If the bidder fails to perform any other obligation(s) under the contract.
- d) Under the above circumstances NIT may terminate the contract / purchase order in whole or in part and forfeit the EMD/PBG as applicable. In addition to above, NIT may at its discretion also take the following actions: NIT may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate NIT for any extra expenditure involved towards goods and services obtained.

10. Applicable Law:

- i. The contract shall be governed by the laws and procedures established by Govt. of India and subject to exclusive jurisdiction of Competent Court and Forum in Dimapur / India only.
- ii. Any dispute arising out of this purchase shall be referred to the Director NIT Nagaland, and if either of the parties hereto is dissatisfied with the decision, the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties, to be appointed by the Director of the Institute. The decision of such Arbitrator shall be final and binding on both the parties.
