21. The bidder should be the manufacturer or authorised dealer and, in such case, the certificate of dealership from the manufacturer should be produced.
22. **Performance Bank Guarantee (PBG):** The supplier shall furnish an unconditional PBG for 5% of the Purchase Order value for a period of one year from a scheduled Bank of India, within 21 days from the date of delivery and installation of the work.  - b) The Vendor shall, at his own cost, rectify the defects/replace the items supplied, for defects identified during the period of guarantee.
