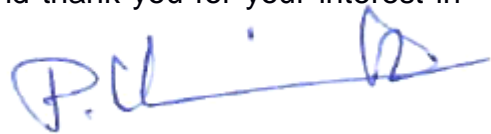

19. The Bidder should have experience of executing at least 5 (Five) Purchase Order of Equipment/Machines from any IITs /NITs/ Central Govt. Institutions or Educational & Research Institutions of National Repute.
20. Vendors should clearly state the available nearest after sales service facilities in the region, without which their offers will be rejected.
21. The bidder should be the manufacturer or authorised dealer and, in such case, the certificate of dealership from the manufacturer should be produced.
22. **Performance Bank Guarantee (PBG):** The supplier shall furnish an unconditional PBG for 5% of the Purchase Order value for a period of one year from a scheduled Bank of India, within 21 days from the date of delivery and installation of the work. Where the PBG is obtained by a foreign bank, it shall be got confirmed by a Schedule Indian bank and shall be governed by Indian Laws and be subject to the jurisdiction of courts at Dimapur.  - b) The Vendor shall, at his own cost, rectify the defects/replace the items supplied, for defects identified during the period of guarantee.

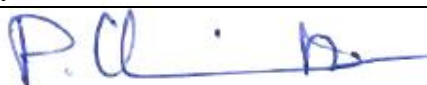
